Lunations and Long-term Aspects

This month will hopefully be a little less intense than last with those two eclipses and Mercury retrograde. Mercury's direct station at 16 degrees further activated the hot spots created by the Saturn - Uranus quincunx that stuck around for six long weeks last summer and caused a few unfortunate issues for those with planets in those degrees, especially if they were Cardinal signs. This month we have two garden-variety lunations and your modern sign ruler, Neptune, stations direct though there's also a Mars - Pluto conjunction and that Uranus - Pluto square is back as well but again those with Cardinal sign Sun or Moon are most likely to feel that so you fishies are relatively safe.

The Full Moon on November 6 is in Taurus, your 3rd house of thoughts, ideas, siblings, neighbors and local travel suggesting an ending, culmination or shift to a new phase of something in this part of your life. Your 9th house is occupied by the Sun, your exalted ruler, Venus and Saturn which are bringing some attention to your beliefs, expectations, higher learning, legal matters, other cultures, long-distance travel and relocation. Your traditional sign ruler, Jupiter, is moseying along in Leo, your 6th house of work, health, service and pets, which could bring some expansion to this part of your life. He's squaring Saturn and Venus which suggests some challenges in that area which could simply indicate you have to go back to school or get some special training in order to progress in your job which isn't a bad thing as a rule. However, whatever is going on in your 9th may cause some disruptions to your finances which require a few adjustments. Those of you born right around March 5 are most likely to be affected.

Mars conjoins Pluto in Capricorn on November 11. No telling what these two bad boys could stir up in your 11th house of friends, groups, organizations, goals, networking, hopes and wishes. It could bring a considerable opportunity to those of you born right around March 2. You folks will have quite a few "hits" this month so keep an eye out for what happens. As noted earlier, these aspects could bring some trouble for those with a Cardinal sign Sun at 11 degrees but they could easily be beneficial for you.

Your modern sign ruler, Neptune stations direct on November 16 and will do so conjunct your natal Sun if your birthday is right around February 23. This could bring a blast of inspiration or insights of a very useful nature. The station chart contains a yod, a.k.a. "finger of God," which tends to have a fated nature about it and is mostly concentrated in 11 degrees, so listen up if you were born on March 2. It appears to involve someone close to you, perhaps even your mother, and information relative to your beliefs or some other 9th house matter as previously defined, the combination of which could bring a sudden change to your finances. Just for fun you might want to buy a lotto ticket and let your mother pick the numbers. Note that I said "ticket," like in singular, because if you're supposed to win you only need one. The odds are so low of winning that buying more than one is simply a tax on those who are bad at math.

The New Moon on November 22 is in Sagittarius, your 10th house of career, reputation, public image and status which could bring you something new in this part of your life. Approach with caution, however, because the lunation and Venus are all squaring

Neptune which suggests all will not be as it may appear. Taking action toward a goal based on research is favored and may bring about a few changes of direction with your work or health. You may continue to encounter some challenges or clashes between work and your beliefs or philosophy of life, however, though these could also be part of what brings the opportunity to go after what you want.

Uranus and Pluto square off at, you guess it, 11 degrees, between November 27 and December 27. This is a time to look at matters resident in your 11th house, i.e. friends, groups and goals as noted above, and see if there's anything that should be eliminated. Hidden information could come about suddenly and it could impact your finances in some way. This could bring an irritation initially but there's potential for it to work in your favor in the long haul.
